The Inland Volleyball Officials Association must certify persons who wish to officiate interscholastic volleyball in the Riverside-San Bernardino area for member schools of the CIF-Southern Section.

- **All officials are required to attend 18 hours of training as imposed by the State CIF. Officials would be well served to attend all listed meetings.**
- Veterans will be assigned to officiate scrimmages around the area on September 8, 9, or 10. This will count as two hours of instruction. In addition, officials who have less than 2 years of experience will be evaluated in game situations as assigned on September 8, 9, or 10.
- **All officials will be required to referee at least two hours at a summer league tournament during the months of June and July.**
- **Note: All officials in IVOA must attend either the Oct 7 OR the Oct 11 meeting and pass the written exam with a score of 80% or better to be eligible for playoffs.**
